

Artists and Arts Organization Mini Grant

Purpose: To improve the quality of life in Pocahontas County by fostering a vibrant arts community. Any artist or organization may apply who wishes to expand knowledge of their discipline, explore new art forms or variations, improve the method or aesthetics for displaying art or extend their range of audience for viewing and purchasing their artwork. Acceptable disciplines include visual art and craft, music, creative writing, poetry, and dance.

Artists or Organizations may apply for up to \$500.

You must submit a brief final report with receipts for grant monies spent within 30 days of project completion.

Eligible for funding:

Workshops, classes, and special arts education programs,
Stipends for guest artists,
Special materials for new creative endeavors,
Materials used to teach classes which are free to the public,
Enrichment experiences for an artist, and
Collaborative art projects.

Not Eligible for funding:

Business expenses not related to the actual creation of art,
Art not created by the applicant,
Requests by individuals or groups who have received a grant in the same calendar year,
Requests by individuals or groups who have previously received funds but have not turned in a final report with receipts,
Projects taking place less than **one month** from application date.

Matching Funds Grant

Purpose: To improve the quality of life in Pocahontas County by fostering a vibrant arts community. To generate art related experiences, learning opportunities or community exposure to an art form. Acceptable disciplines include visual art and craft, music, creative writing, poetry, and dance.

Grants for matching funds are provided to organizations seeking funding from other sources that require matching funds. The maximum matching funds grant awarded is \$500. For example, if the project budget is \$1000, your organization must have \$500.00 to use the monies for the project directly from us. Your organization may also use up to \$500 of the grant as matching funds for other sources.

You must submit a brief final report with receipts for grant monies spent within 60 days of project completion.

Eligible for funding:

Community arts events,
Special materials for shared artistic experiences,
Materials used to teach community arts classes (free to the public),
Collaborative arts experiences, and
Creation of community resources for artists.

Not Eligible for funding:

Business expenses not related to the creation of art,
Commercial enterprises,
Requests by groups that have received a grant in the same calendar year,
Requests by groups that have previously received funds but have not turned in a final report with receipts, and
Projects taking place less than **two months** from application date.

Sponsorship Grant

Purpose: To improve the quality of life in Pocahontas County by fostering a vibrant art's community. Funds are provided for organizations holding artistic and cultural events in Pocahontas County. These funds can be used for fairs and festivals especially those that emphasize Appalachian art, folk art, and culture (including, music, dance, creative writing, and poetry) special events featuring the work of fine art and craft.

These funds are for events with budgets over \$1,000.

The Pocahontas County Artisan Co-Op's logo must appear on all literature for the event.

You must submit a brief final report with receipts for grant monies spent within 60 days of project completion. Also include copies of promotional materials or ads displaying the Pocahontas County Artisan Co-Op logo.

Eligible for funding:

Projects which add an arts component to fairs and festivals,

Projects which promote public appreciation of the arts,

Projects which encourage collaboration between various community arts organizations.

Not Eligible for funding:

Business expenses not related to the celebration of art.

Events not free to the public,

Requests by organizations who have previously received funds but have not turned in a final report and receipts,

Events scheduled for less than **three months** from application date.
